The Providence Revolver Club is a private indoor pistol club that requires the following steps for membership:

1. Your ability to completely follow the procedures set up in this application will weigh heavily in the Executive Board's decision to accept you as a member of this club. Following instructions is the most critical element of Firearms Safety. We feel if you cannot follow instructions set forth herein, you probably will not be able to follow Firearm Safety Instructions as well.
2. **Step-1** Complete this application in **LEGIBLE** print. Upon submission of your application, be sure to include all required documents.
 - A completed signed/dated application.
 - A non-refundable \$100.00 application fee in the form of check/money-order **no cash**.
 - A copy of an official current/active photo identification Driver's License, Passport. ...etc.; (we will need to see the original official photo identification);
 - Proof of current NRA membership: (Membership is Required)
 - A current original (no copies) **BCI report from the Office of the Rhode Island State Attorney General not older than 30 days with no outstanding arrests.**

All of the above must be submitted to the Club before any action is taken on your application.

3. **Step-2** After step one is completed, you will be scheduled for an interview with the Executive Board.
4. **Step-3** After the approval of your application from the Executive Board, you will then be required to attend and successfully complete our in-house NRA Certified Training and Qualification Course (i.e. T&Q). The T&Q course instructs you in GENERAL FIREARMS SAFETY and SAFE HANDLING PRACTICES of firearms within the confines of the facility. This Session is taught by our NRA Certified instructors. The session runs approximately 5-6 hours and usually held on a Sunday morning. It includes an academic phase with classroom discussion and participation; and a live-fire session on our range using Club Owned firearms. You may be asked if you would like to fire one or more of your own guns, however this will be at the discretion of the Training officer.
5. **Step-4** The final step in becoming a member will be to pass the NRA Basic Pistol Course's Test, and the approval of your training by the Training and Executive Officers. They then will offer their recommendations to the Executive Board regarding your membership. The Executive Board will take into account the Training and Executive Officers' recommendations in making its final decision on your membership. All fees must be paid upon acceptance into the Club before an access key fob is issued.

Fees:

- \$100.00 - Application fee (due with the application) (non-refundable)
- \$100.00 - Building Assessment Fee (one time only) Paid when accepted into the club
- **Prorated dues for this application only at the rate of \$ 21 per month for the remaining months of this year. Annual dues are \$220.00 per year.* Dues are due on January 1 for the upcoming year. For renewal of your membership and dues payment, you will be reminded by email only. If you do not use email, you must make other arrangements with the treasurer. There will be no snail mail invoices sent out.**
- \$ 20.00 - Key Fob Deposit (returned when key fob is surrendered) an additional \$20 charge for a lost or replacement Key Fob
- **Total:** \$440.00 First year costs **LESS** approved dues apportionment. *Note as of January 1, 2023 the dues will be \$ 250.00/year.
