The Providence Revolver Club is a private indoor pistol club that requires the following steps for membership:

- 1. Your ability to completely follow the procedures set up in this application will weigh heavily in the Executive Board's decision to accept you as a member of this club. Following instructions is the most critical element of Firearm Safety. We feel if you cannot follow instructions set forth herein, you probably will not be able to follow Firearm Safety Instructions as well.
- 2. <u>Step-1</u> Complete this application in <u>LEGIBLE</u> print. Upon submission of your application, be sure to include all required documents.
 - > A completed signed and dated application.
 - > A non–refundable \$ 100.00 application fee in the form of check/money-order **no cash**.
 - A copy of an official current/active photo identification Driver's License, Passport. ...etc.; (we will need to see the original official photo identification);
 - > Proof of current NRA membership: (Membership is Required)
 - A current original State of RI Attorney General issued BCI (no copies) BCI report not older than 30 days with no outstanding issues.

The above docs must be submitted before any action is taken on your application

- 3. <u>Step-2</u> You will be scheduled for an interview with the Executive Board.
- 4. <u>Step-3</u> After accepting your application by the Executive Board, you will then be required to attend and successfully complete our in-house NRA Certified Training and Qualification Course (i.e. T&Q). The T&Q course will instruct you in <u>GENERAL FIREARMS SAFETY and SAFE HANDLING PRACTICES</u> of firearms. This course is given by our NRA Certified instructors. The course runs approximately 5-6 hours and is usually held on a Sunday morning. The course includes an academic phase with classroom instruction and participation; plus a live-fire session using <u>Club Owned firearms</u>. You may be asked if you would like to fire one or more of your own guns, however this will be at the discretion of the Training Officers. If we are not able to have you attend our training and safety course in due time, we will give you an abbreviated training and safety course. However, you must successfully take the comprehensive NRA course at **NO** additional expense to you within six months therefrom.
- 5. <u>Step-4</u> The final step will be to pass the NRA Basic Pistol Course's Test. The T&Q officers will then submit their recommendations to the Executive Board. The Executive Board will take into account the T&Q officers' recommendations when making its final decision on your membership. All fees must be paid upon acceptance into the Club before a key fob is issued to you.

- \$100.00 Application fee (non-refundable) (due with this application)
- A one-time Building Assessment Fee of \$ 100.00, or no fee option of working 10 hours for the club within one year of becoming a member. Prorated dues for this application only at the rate of \$ 25 per month for the remaining months of this year. Annual dues are \$250.00 per year. Dues are due on January 1 for the upcoming year. For renewal of your membership and dues payment, you will be notified by email only. If you do not use email, you must make other arrangements with the treasurer for options. There will be no USPS mail invoices sent out for dues reminders.
